- F. Road Sign Mr. Herndon will have a sign fabricated and installed on the north side of Willbrook Boulevard to provide direction to the Tradition Golf Course entrance
- G. Rental 255 Tradition Club Drive Mr. McLeod will send a letter to the owners of this address reminding them of the requirement that rentals must be at least 6 month duration.
